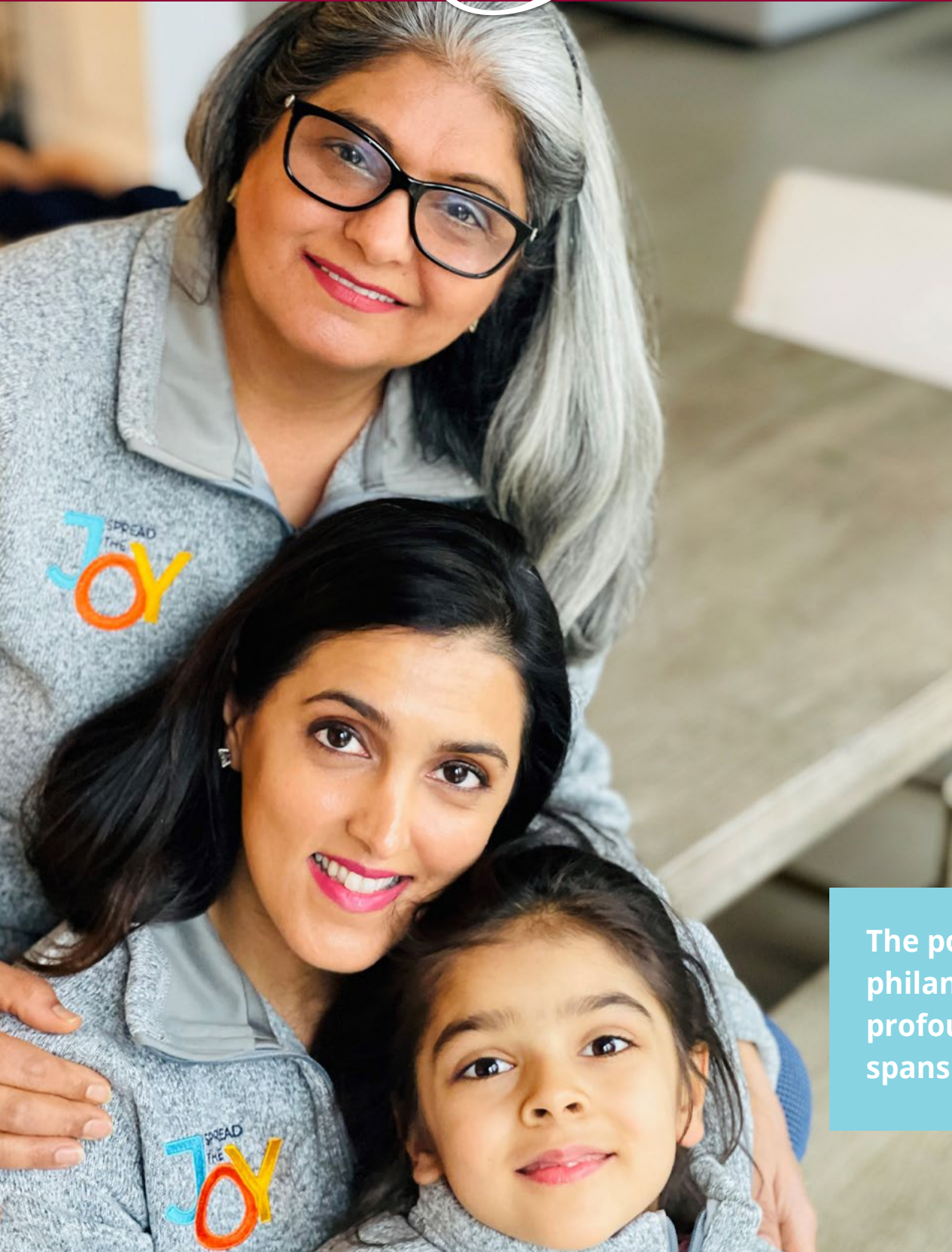

In the case of the Spread The Joy Foundation, founder Shalini Samtani was inspired to give back during a particularly trying time for her family. Her young daughter was diagnosed with an extremely rare immune disorder. In and out of hospitals, including Garnet Health Children's Emergency Department (ED), Shalini's son asked, "How will Santa know where to find kids if they are in the hospital on Christmas Eve?"

In response, the family mobilized overnight to create holiday boxes full of activities. Within days, several boxes were delivered to their local hospital, return-addressed from the North Pole. The following month they created another themed box, and Shalini discovered that she found joy in the process.

"It became therapeutic to us as a family," said Shalini.

Established in 2017, the Spread The Joy Foundation has gifted approximately 10,000 Joy Boxes to Garnet Health Medical Center and 124 other medical centers. Shalini reflected on her time at Garnet Health Children's ED and their visit from the Child Life Specialist, saying, "It takes so little to make a child happy."

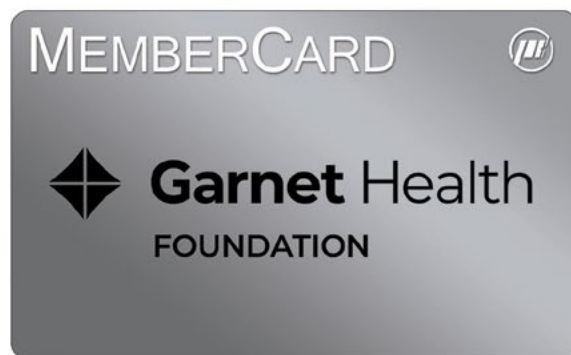

Garnet Health President & CEO Scott Batulis Announces Retirement at Year-End

After 15+ years of service at the Hudson Valley's premier health system, Scott Batulis has announced plans to retire as President and CEO of Garnet Health, effective Jan. 1, 2022. Garnet Health's Board of Directors will begin a formal search and selection process soon, with the expectation of appointing a new President and CEO of Garnet Health later this year. Mr. Batulis will remain in his current position for the remainder of his contract to the end of 2021 to ensure his replacement's smooth transition. Afterward, he plans to serve Garnet Health as a consultant for six months, and then become an active volunteer.

"Serving as President and CEO has been a challenging and rewarding journey, and the highlight of my 38-year career in healthcare administration," said Mr. Batulis. Prior to joining Garnet Health in 2006, Mr. Batulis spent nearly 20 years with HealthEast Care System, a network of integrated care services including hospitals, clinics, rehabilitation, and specialty care facilities headquartered in St. Paul, Minn. Within this network, he held the positions of Vice President of HealthEast Care System, Chief Executive Officer of St. Joseph's Hospital, and Chief Executive Officer of Bethesda Rehabilitation Hospital.

Thanks to Mr. Batulis's leadership, this organization has celebrated remarkable achievements, including the building of the first new hospital in New York in 25 years, the merger with Catskill Regional Medical Center, our role in bringing Touro College to Middletown, the creation of Graduate Medical Education programs, the Level II Trauma program, the growth of Garnet Health Doctors, the development of Urgent Care, and the numerous quality awards such as America's 250 Best Hospitals, Magnet Nursing designation, and all of our Healthgrades Clinical Excellence Awards.

"It truly has been my honor to serve Garnet Health, especially during the pandemic," Mr. Batulis said. "I could not have imagined how difficult it would be, nor how far we would have to go 'above and beyond' to meet this challenge. Our employees' dedication and commitment to our patients and our community during the pandemic has been amazing."

Mr. Batulis continued: "I am grateful to have served as President and CEO of Garnet Health. In retirement, I will enjoy spending more time with my wife, children, and grandchildren, and pursue my interests in art, music, and golf."

As of April 14, 2021, over 30,000 vaccines have been administered at Garnet Health.

A retired RN after 41 years at Garnet Health, Leone had had enough. She had lost the love of her life, her husband John, to COVID-19 in April of last year after 44 years of marriage. Luckily, she had her two daughters, Nicole and Michelle, to provide the needed love and comfort. When Leone heard the Vaccination Center at Garnet Health Medical Center had activated, she called and offered her help.

"It was so wonderful to be back at the hospital," said Leone. "It was 'old home week' for me. So many of my former co-workers came to see me, and the newer folks welcomed me with open arms."

A longtime member of the Foundation's 21st Century Club, Leone derived her greatest joy from the patients she vaccinated. Many asked for "selfies" with her and thanked her profusely. Her days in the Vaccination Center are filled with continuous compliments. She had found her way to deal with her own personal grieving by helping others.

"The people I vaccinate see it as a very special gift and are so thankful," said Leone. "I now often wish them a Merry Christmas and Happy Birthday!"

Leone said she is most proud of the incredible, well-tuned, and efficient operations of the Center, where as many as 600+ patients are vaccinated per day. There is something quite moving that is the result of the hospital's support for this Center, combined with the joy on staff faces while they provide this life-saving service. Her favorite moments so far have been her chance to vaccinate a 97-year-old; Leone was also there the day that a 103-year-old was vaccinated in his car by Chris Costello, RN, Director, Employee Health.

"They are all gift givers," Leone said. "And it's everyone who is involved – from nurses to the volunteers. It is an operation that only works because every spoke in the wheel moves in unison."

"Everyone will remember where they were when a global event occurred, whether it was the space shuttle, assassination of JFK or John Lennon, or 9/11, and COVID-19 is no different," said Leone. "We all feel so unsettled without all of our customary gatherings of family and friends, coupled with so many people you know being sick."

Leone continued: "I may be an old hippy, but I really believe that coming together to take care of others is the only way out of this terrible pandemic."

GROUNDBREAKING FOR GROWTH: EVERY MINUTE COUNTS LAUNCH

April 7's groundbreaking ceremony marked the beginning of work to construct a 620-space parking garage following months of initial groundwork and relocation of the helipad. The garage is a requirement for any expansion of the hospital, an important domino effect ushering the next phase, which will include expansion of the emergency room and trauma center.

"This groundbreaking stands for far more than the literal breaking of ground," said Brian Tew, Garnet Health Medical Center CEO. "It stands for a brick-and-mortar milestone for our hospital, and is the result of us outgrowing this beautiful facility. It stands for our Board of Directors' groundbreaking wisdom in choosing to invest in a future that last year taught us, can be difficult to predict. And it stands for the groundbreaking generosity of donors, and the support of our physicians, community leaders, administration, and staff."

Garnet Health Board Chairman Don Beeler said that the garage is an important endeavor empowering us to expand our wide range of services by creating new parking spaces for employees as the number of patients and visitors of the hospital, as well as the number of Garnet Health doctors, continues to grow.

The event took place adjacent to the construction site for the new garage. A small crowd of socially-distanced Board members, executives, clinicians, and public officials gathered under warm spring skies to celebrate this next hospital expansion phase.

Town of Walkkill Supervisor Frank DenDanto said the expansion and success of the hospital has been personal for him, as he is the son of a nurse from Horton Medical Center. He said the expansion process never lost a beat, even during COVID-19, which is a testament to Walkkill's commitment to the hospital's growth.

Foundation President Bill Dauster said a fundraising campaign called "Every Minute Counts" has been developed, and is a salute to the importance of getting quality care in a timely way for all patients, especially for our heart and trauma patients. The campaign has been accepting gifts and providing naming opportunities to donors at all levels, one of which has been a seven-figure gift.

"Today it is with great pride that we announce that to date we have raised \$3 million towards our \$7 million goal, truly a testament to both the critical nature of the project and the wide belief our business and residential communities will support it," said Mr. Dauster. "We typically call this time the 'Quiet Phase' of a campaign, but today that phase ends; we now invite everyone to participate."

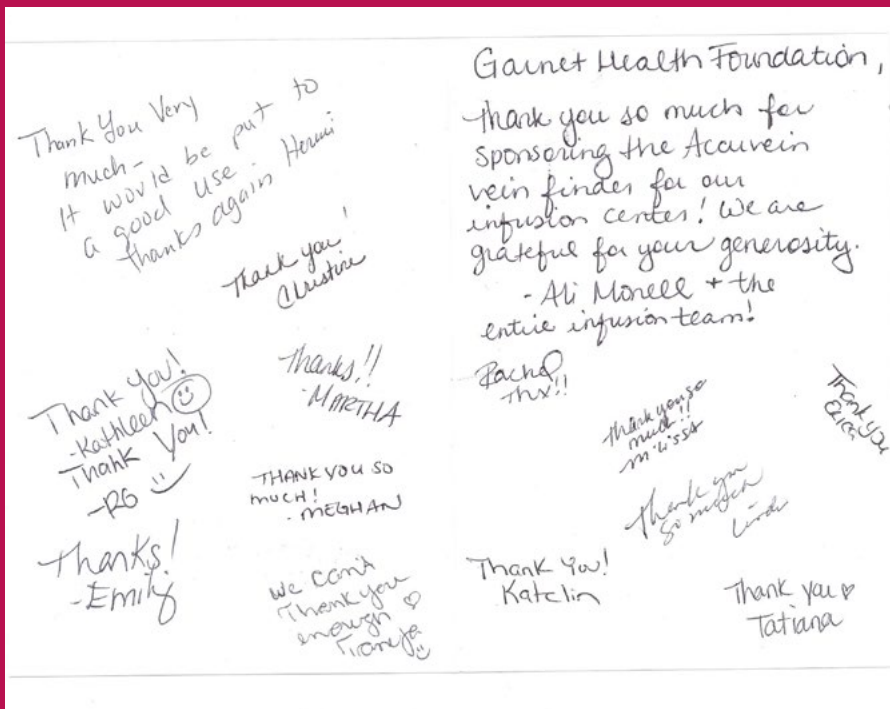

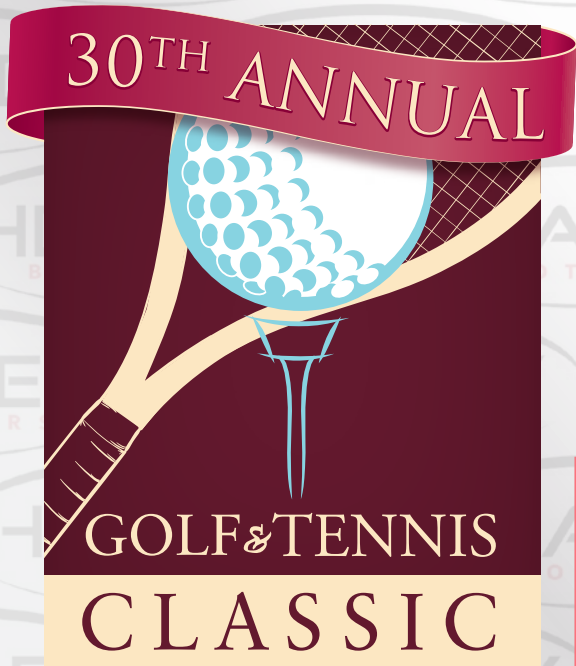
