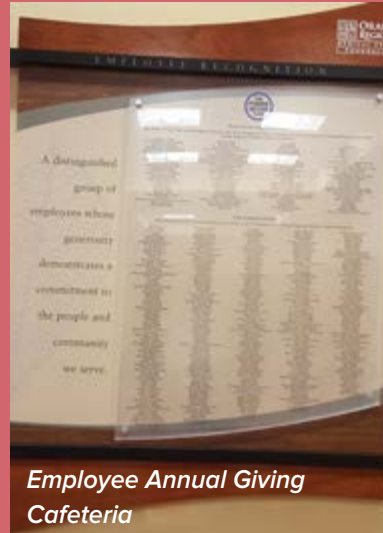

PLANS FOR THE FUTURE

Emergency Department

Orange Regional's leadership understands the pressures on the hospital's Emergency Department. A full study of the Department's volume and processes was recently completed by an external, nationally known firm. The information and data are being used as a framework to redesign and expand the facility.

While new processes were immediately implemented and have been effective at expediting care, expansion

has also been deemed necessary. A Clinical Decision Area is also being constructed for those patients too sick to be sent home from the Emergency Department; a summer 2019 completion is planned.

An announcement of the full expansion plans for the Emergency Department will be later this year. The plans will include nearly twice as many treatment bays, additional parking, and a new helicopter pad.

A Newly-Renovated Training Room For Emergency Department Residents

Space might be ORMC's greatest challenge as it continues its journey as a teaching hospital.

Recently, Dr. Anuj Vohra, Chief, Emergency Medicine, made the case to the Foundation Board that training Emergency Department physicians in another building during busy times in Emergency Department wasn't exactly a prudent choice.

"We really have to be accessible and available all the time," said Dr. Vohra, "but our students require didactic learning time."

The Facilities Department recommended refurbishment of an ER "breakroom," and the Foundation Board agreed to fund the room's technology needs.

"We are really grateful for the Foundation's support and the great work of the Facilities Department in making this a functional and comfortable learning environment," said Dr. Vohra.

ORMC Readies For Trauma Center Survey

ORMC administrators are hopeful that years of hard work will prove beneficial when the American College of Surgeons (ACS) trauma accreditation survey is conducted in mid-April.

Two years ago, ORMC received provisional certification as a Level 2 Trauma Center from the State of New York. Formal approval from ACS would bring the Center to full accreditation, and provide a host of

new community and patient benefits. This effort fits strategically with plans for an expanded Emergency Department that can better support those in the growing business and residential developments and the region's added commuter traffic volume.

It has become common for ORMC to welcome patients from as far away as Pennsylvania.

"We have made significant strides to get ready for this survey. Despite being a provisional Level 2 Trauma Center, our trauma patient volume tripled over the last 3-year period. Our risk-adjusted outcome data for trauma patient care compiled by the National Trauma Quality Improvement Program is on par with any established trauma center, which is a matter of great pride to our amazing team of trauma surgeons, neurosurgeons, orthopedic surgeons, advanced practitioners, nursing, and other support services," said Dr. Mohammad Siddiqui, MD, Trauma Surgeon/Trauma Program and Acute Care Surgery Medical Director, Director of Surgical Intensive Care Unit.

Dr. Siddiqui said ORMC is extremely proud of the physicians who have signed on during the past couple of years. Those physicians include Krassimir Atanassov, MD; Mohamed Elfar, MD; Charles Fasanya, MD; Raghuram Gorti, MD; Eric L. Martin, MD; Jose B. Toro, MD; and Cleveland Lewis, MD.

"These are extraordinary physicians," said Dr. Siddiqui. "We believe having patients staying locally for their care and a new level of trauma survivor support services will be much better for patients and families alike."

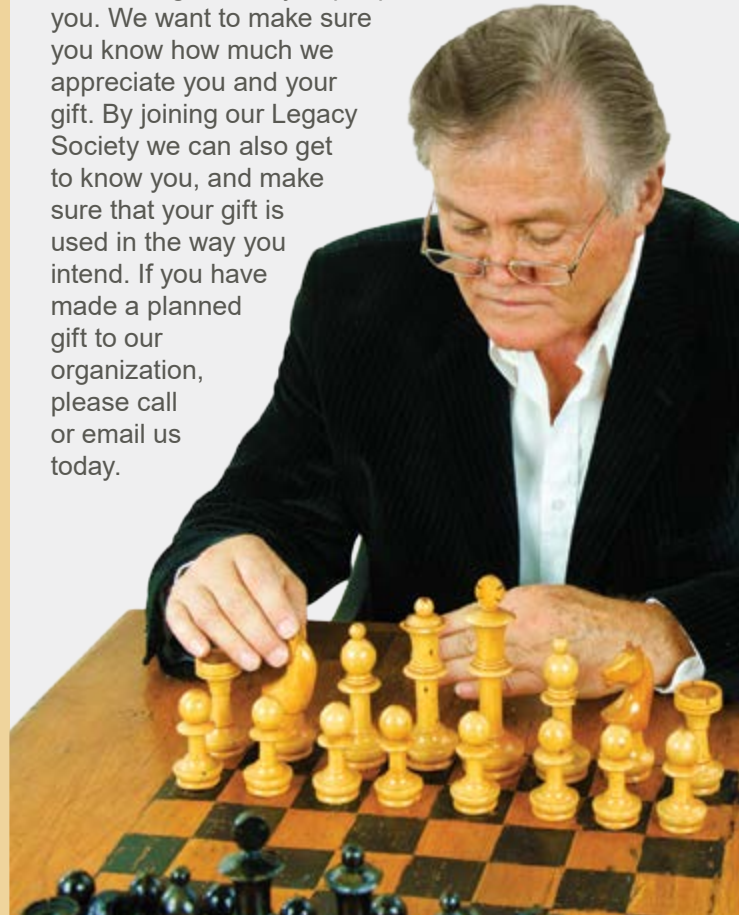
